**Meeting Items**

Introductions

Each attendee introduced themselves to the group.

Current Measures Recap

Both current measures on the KY Core Healthcare Measures Set (KCHMS) were scored collectively at the previous meeting and approved for the 2019 KCHMS subcommittee recommendations:

- Plan All-Cause Readmissions | Collective Score: 13
- Use of Imaging Studies for Low Back Pain | Collective Score: 11

Potential Measures Review

Subcommittee members used the results of the rubric scoring submissions to discuss the potential chronic and acute measures currently up for review on the 2018 KY Core Healthcare Measures Set:

- Non-Recommended Cervical Cancer Screening in Adolescent Females | Average Score: 7.0
- CG-CAHPS | Average Score: 6.5
- Proportion of patients with a chronic condition that have a potentially avoidable complication during a calendar year | Average Score: 9.8

The subcommittee members agreed to recommend to the Oversight Committee the addition of CG-CAHPS to the 2019 KCHMS.

The discussion for each measure was as follows:

- Non-Recommended Cervical Cancer Screening in Adolescent Females (Will Not Recommend)

- Getting unnecessarily screened for cervical cancer screening can result in more harm than benefits for adolescent females and uses unnecessary resources, but we want to push proper preventive care and work on getting the Cervical Cancer Screening (CCS) measure done correctly first.
- At some point, however, we need to start recommending measures that address overutilization.
- CG-CAHPS (Will Recommend)
  - There are many barriers to succeeding in this measure, including resource burden on smaller practices and administering the survey properly, as a whole. However, we have to start somewhere, and including this measure on the core set validates the importance of it.
- Proportion of patients with a chronic condition that have a potentially avoidable complication during a calendar year (Will Not Recommend, Will Add to Future Development List)
  - When thinking about measuring resource use, looking at avoidable complications, including ED utilization, for individuals with chronic conditions is it. However, as this measure no longer has NQF endorsement and isn't being used in any programs, it is not ready for recommendation for the 2019 KCHMS. The committee will continue to monitor this measure and look for more alternatives that track this important area.

### Measures Recommendation Discussion

Stephanie explained the next steps for the committee, including sending out a summary of decisions and rationale for the group to review ahead of the July 23 Oversight Committee Meeting.

The committee made one final statement to also recommend a total cost of care measure for future development.
